SELF-ADVOCACY EMPOWERS PEOPLE AND CREATES OPPORTUNITIES

The SourceAmerica Grassroots Advocacy Conference is an annual event that brings together AbilityOne employee self-advocates and nonprofit representatives to learn about disability employment policy issues affecting them.

The conference focuses on systems change advocacy, with an emphasis on educating policymakers about important programs that benefit people with disabilities.

Tresco is honored to have Lydia Hernandez, Lead Custodian at Las Cruces Federal Courthouse, and Shaun Adcock, Rest Area Repair Tech, as our 2022 Grassroots Advocates. This year the self-advocates will attend a virtual two-part training before heading the Washington D.C. in June for the conference.

On February 22nd Lydia and Shaun attended **Part 1:** Finding Your Voice virtual training. At this training the self-advocates were provided a roadmap by focusing on practical approaches to being a self-advocate in your own community. During the training there were guest speakers and breakout group sessions in developing a better understanding as to how become a strong self-advocate.

On March 24th Lydia and Shaun participated in **Part 2: Telling Your Story** virtual training. The story of the self-advocate's journey is the most compelling element of self-advocacy. During this course Lydia and Shaun focused on developing and presenting their story to the attendees in preparation for using their voice when meeting with business leaders and elected officials in our communities.



ABLE ACCOUNTS AND SPECIAL NEEDS TRUSTS



The Achieving a Better Life Experience "ABLE" Act was passed by Congress in 2014. A STABLE account is an investment account made available to people with qualifying disabilities. These accounts allow people to save and invest money without losing other benefits such as SSI and Medicaid. Earnings from STABLE accounts are not subject to federal income taxes, provided that the money withdrawn from these accounts are used for "qualified disability expenses".

Similar to a STABLE account is a Special Needs Trust "SNT". Special Needs Trusts are a legal arrangement and fiduciary relationship that allow people with physical or mental disabilities to receive income without reducing eligibility for public assistance programs like Medicaid and SSDI.

A difference between an ABLE account and a SNT is that an ABLE account can be managed by the beneficiary themselves, whereas the SNT is managed by a fiduciary for the benefit of the beneficiary.

In weighing the pros and cons of which type of account a person with a qualified disability should choose, the person and their family should visit with a certified financial planner, a financial services representative, and/or a special needs planning attorney.

TRESCO HOME AND COMMUNITY BASED WAIVER PROGRAM

On February 28, 2022 Tresco, Inc. exercised the option to terminate Provider Agreement 21.2021.665.0007.4689 (Home and Community Based Waiver Program) with the New Mexico Department of Health. The agreement requires that a thirty-day (30) day notice be given by the Provider to terminate its agreement, but we believe that is insufficient to ensure an orderly and safe transition for participants of the program. Because of that fact we are giving a one-hundred-and-twenty (120) day notice with the termination date being June 30, 2022.

Tresco has been a provider of services for fifty-four years and has been called "home" to hundreds, if not thousands, of persons with disabilities through our affiliation with the New Mexico Home and Community Based Waiver program.

We will work with all Interdisciplinary Teams, Developmental Disabilities Service Division and families to make sure that our participants are safely and effectively transitioned to another community provider.
